SAD NEWS, TONI SALOMETO- I regretfully report the death of our colleague and friend, Toni Salometo, who passed away on 1/26/2024. Toni, a life-long insurance professional from New Jersey, moved to Century Village in 2009, and immediately began her service to our Community, starting with her home Association's Board in 2010, then with the UCO Insurance Committee and the *UCO Reporter*. After being appointed to chair the UCO Insurance Committee, Toni reorganized the UCO Insurance Office, streamlined the wind mitigation report and claims process for CV Associations, and instituted an open competitive bidding process for the UCO Insurance Program, saving CV unit owners millions of dollars over the last fourteen years. I will remember my friend's example of selfless community service, and her stock phrase, "Bottom line here folks...".

**PLYMOUTH POOL CLOSED-** Last week, UCO received reports of children swimming in the Plymouth Pool, This pool was closed by the Palm Beach County Department of Health in December, 2023 and has not yet been recertified for use. The entry gates to the pool deck are now padlocked, the pool is cautioned taped off to deter people from swimming in this pool, and "POOL CLOSED" signs have been posted.

MANIAC THROWS GARBAGE INTO NORTH CANAL FOR NO PARTICULAR REASON- On 1/17, Rafael Sencion, owner of 417 Sheffield Q, threw a load of trash into North Canal. A video recording of this disgusting behavior was sent to UCO. I directed Seacrest Services to remove the trash, and to send an invoice to the Sheffield Q Condominium Association. This Association will, in turn, invoice Sencion for his disgusting behavior. The cost for this cleanup is five hundred dollars. Treat our Community like a garbage dump, pay for the cleanup.






