STORM DRAIN REPAIRS- Last week, Anchor Marine repaired a storm drain pipe at the Oxford section of CV. This pipe had previously been found to be rotted out, causing a subsidence at the front lawn of Oxford 300.

PLYMOUTH POOL- This pool remains closed, after multiple violations were found by the PBC Department of Health. This pool has been refilled, and the entry gates to the pool have been padlocked. CV residents should not use this pool until it is re-certified for use by the PBC Dept. of Health.

EMERGENCY GENERATORS- On 1/2, The Generator People performed scheduled maintenance of the emergency generators at the Okeechobee Boulevard Guardhouse and the UCO Office. This maintenance included check of oil and coolant levels, inspection of the air cleaning filters, and fifteen minute no-load test run of the generator. Propane fuel supply was confirmed at both generators, approximately 350 gallons and 700 gallons. All three of UCO's emergency generators (2 guardhouses, UCO Office) are under annual maintenance contracts, and are serviced every other month.

SEMIANNUAL WATER SYSTEM FLUSH- On 1/4, PBC Water began semiannual flushing of the CV potable water system. There may be a slight chlorine smell to the water coming out of our faucets, but this is harmless and the water is safe to drink. See the notice from PBC Water, appended to this report, for more information.

BICYCLES IN TRAFFIC LANES- Our security contractor reports that a growing number of bicyclists, tricyclists, and mobility scooterists continue to enter and exit Century Village using the vehicle lanes rather than the pedestrian walkways. This is dangerous. On 1/4, a tricyclist got whacked in the head by a gate arm when she piggy backed behind a car. Our gate arms can only detect cars and trucks. They cannot detect pedestrians, cyclists or scooterists, and mixing in with cars and trucks at these busy roadway points is also dangerous.

SOUTH FLORIDA FAIR- On **1/22/24**, UCO will provide bus service to the South Florida Fair. The first bus to the Fair will leave the Century Village Clubhouse at 11:00 AM and the last bus to the Fair will leave the Century Village Clubhouse at 3:00 PM. The last bus to return to CV will leave the Fair at 4:00 PM.

IRRIGATION- On 1/02, Chabot Irrigation performed monthly mechanical/electrical maintenance and flowmeter readings at all 27 CV irrigation pumps, and reported irrigation water usage to the South Florida Water Management District. Monthly recording and reporting of CV's irrigation water use is a SFWMD requirement.

UNREGISTERED AND DERELICT VEHICLES- A number of derelict vehicles and vehicles with expired registration tags were reported to PBC Code Enforcement. Notices of Violation will be sent to the CV Associations that allow these vehicles to be stored on their properties. See PBC Ordinance 2007-013, 2019-005, 2019-034: "It shall be unlawful for any owner of land in any residential district to park on, cause to be parked on, or allow to be parked on residentially zoned land any unlicensed or unregistered vehicle." "It shall be unlawful for the owner or occupant of a building, structure or property to utilize the premises of such property for the open storage of any motor vehicle which is inoperable and in a state of disrepair."

CABLE TELEVISION- Our cable television provider, Breezeline, has announced that starting on 1/9, all non-TIVO cable boxes will no longer support Video-On-Demand (VOD) service. See the flier that is appended to this report for more information, or visit the Breezeline Cable Store at 5400 Fairway Street.

STREETLIGHTS- On 1/7, FPL sent repair crews to Century Village, to repair sixteen dark streetlights at various sections of CV.



OXFORD SECTION- THIS UNDERGROUND STORM DRAIN PIPE WAS FOUND TO BE DAMAGED.




