CANDIDATE'S FORUM- On 2/2, the candidate's list for the 3/1 UCO Annual Elections was finalized. There are two candidates for UCO President, two candidates for UCO Treasurer, six candidates for UCO Vice President, one candidate for UCO Recording Secretary, one candidate for UCO Corresponding Secretary, and fourteen candidates for the UCO Executive Board. On 2/8, over 100 CV unit owners attended a Candidate's Forum, where CV unit owners running for UCO offices communicated with their neighbors. This event was recorded, and can be viewed on our Community TV Channel 592 and at www.unitedcivic.org.

IRRIGATION- Century Village's irrigation system depends on 27 UCO maintained irrigation pump stations, located throughout the Community. These installations require regular repairs and preventive maintenance to provide reliable irrigation service to the CV association properties. Last week, Chabot Irrigation performed repairs and maintenance at pump installations in the Coventry and Bedford sections.

REFLECTION BAY, HOMELESS CAMPS- Our security contractor, Platinum Security, continues to find pushed down sections of construction fence, and also occasional "hop overs" by unauthorized persons from the Reflection Bay property. I have sent reports to PBSO, PBC Code Enforcement, and to the owners of the Reflection Bay property. Platinum Security is patrolling these areas; pushed down sections of perimeter fence are repaired when discovered. On 2/9, PBSO Deputies, led by Sergeants Hightower and Robinson, removed seven homeless persons from this property. The property owner, Kolter Land, will clean up the camp areas and repair the fence along Haverhill Road to deter future trespassers.






