TRAFFIC, HAVERHILL ROAD ENTRANCE- On 3/10, there was a traffic accident on the east side of Haverhill Road, involving a CV unit owner exiting Congregation Aitz Chaim and a car headed north on Haverhill Road. The intersection of Haverhill Road and Century Boulevard has been tricky for some time, with drivers entering and exiting CV and the Synagogue competing with cars traveling north and south on Haverhill Road. The PBC Engineering Department is aware of this problem, and is working on a solution, involving directional arrows and possibly adjustments to the traffic lights at this spot. In the meantime, and especially during this high occupancy season, please drive carefully at this intersection.

STOLEN U HAUL TRUCK- A U-Haul truck, parked at Kingswood D for several weeks, was reported by U-Haul as stolen. The driver of this truck was listed as a guest staying in 72 Kingswood D. PBSO was called on 3/20 (Case # 24045282). The truck was towed off property the same day.

CUT FENCE, NORWICH SECTION- A CV unit owner reported that people were entering the Community through a hole that was cut into the perimeter fencing near the corner of Haverhill Road and Community Drive. Investigation by Platinum Security revealed that the people moving through the hole were coming from a vacant property that is adjacent to Century Village. A report was sent to PBSO, case #24044970. Temporary repairs to the cut fence were made on 3/19; permanent repairs were made on 3/20. A letter was sent to the owner of the vacant property, requesting that the property be secured. Additional hidden "stealth cams" were installed to keep an eye on this spot, and PBSO NO TRESPASSING signs were installed at the fence. Two old tricycles, presumably stolen, were found near the fence hole; these were put into storage at the Plymouth Laundry. If these trikes belong to you, please let me know and we will get them back to you. Pictures of the trikes are appended to this report.






