**UCO TOWN HALL MEETING-** On **5/17**, UCO President Fausto Fabbro hosted an open Town Hall style meeting at the CV Clubhouse. This meeting was very well attended, and addressed a wide range of topics concerning life in Century Village. These meetings will now be held monthly on the third Thursday of each month. **TRANSPORTATION-** On **5/13**, Academy Bus delivered two brand new buses to Century Village. These buses will be used for external service.

**SHREDDING EVENT-** On **Friday, 6/7**, UCO will host a document shredding event at the CV Clubhouse lobby. Hours of service will be **8:30 AM until 12:30 PM**. A flier for this event is attached to this report. Please post this flier to association bulletin boards.

**SWING GATE SMASHED, HAVERHILL ROAD EXIT LANE-** On **5/15**, a truck belonging to an FPL contractor smashed a swing gate at Century Boulevard. The gate will be replaced; the contractor will be invoiced.

**BULK TRASH**- Last week, there were a number of cases of large rubbish piles and improper disposal of construction and demolition debris at CV. Resolving these conditions is time consuming and frustrating, and the piles are very unsightly. CV Boards need to watch out for refurbishment projects and clean outs, and make sure that no construction, demolition, or unit cleanout debris is placed in the residential dumpsters. Maintaining community standards is a joint responsibility of all CV unit owners, and their management companies. Let's all help with keeping Century Village clean!

**SUMMER PROJECTS-** With peak occupancy season about over, we have resumed work on "summer projects". This year, we are concentrating on speed bumps, stop signs, and stop bars at secondary and tertiary roads. At many of these locations, stop bars and speed bump paint have faded, and many of these stop signs are not FDOT compliant (too short, too small, faded). Right now, our Glow Cleaning Plus maintenance person, Jose, is working on higher traffic intersections, using FDOT compliant road paint.

SENIORS VS. CRIME- Century Village is very fortunate to have a SENIORS VS. CRIME program, based at the UCO Office (2102 West Drive). This volunteer staffed program, sponsored by the Florida Attorney General's office, investigates complaints and seeks restitution for seniors in appropriate instances, free of charge. All monies recovered go to the complainant. CV residents who are involved in civil situations can request assistance, and the Senior Sleuths assigned to the case will do everything possible to reach a settlement without cost, and without public or family embarrassment. Senior Sleuths are successful in a high percentage of cases. The CV Senior Sleuth Team has regular open office hours at the UCO Office, on Wednesdays, 12:00 PM to 3:00 PM, or by appointment (1-800-203-3099), or email:
